Treasurer's Report:

General Fund (GF) Checking account: balance as of 10-31-2025 was \$383,431.02.

The GF checking account has been reconciled in Xero through 10-31-2025 noting no difference.

Capitol Improvement Fund (CIF) Checking: account balance as of 10-31-2025 was \$226,560.31. The CIF Checking account has been reconciled in Xero through 10-30-2025 noting no difference.

Petty Cash: Petty cash was counted by Nicole Oelschlaeger on 11-06-2025. She stated the total on hand was \$77.15.

- **Bonuses for volunteers:** The board discussed providing gift cards in the amount of \$200 to both the historian and the quilting group leader. Chris made a motion to approve, Aly seconded, and the vote was in favor.


